ORDINANCE DECLARING NO. 156, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED **"AN ORDINANCE CREATING ONE (1) POSITION OF ENGINEER II UNDER THE OFFICE OF THE MUNICIPAL ENGINEER AND** ONE (1)POSITION OF **ADMINISTRATIVE** AIDE (COTERMINOUS) UNDER THE OFFICE OF THE MAYOR OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG **BAYAN TO ENACT**
