PROVINCIAL RESOLUTION NO. 717-2020

INVITING THE REGIONAL DIRECTOR OF THE DEPARTMENT OF EDUCATION AND THE PUBLIC SCHOOLS DISTRICT SUPERVISORS OF PANGASINAN I TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN ON ITS AUGUST 3, 2020 REGULAR SESSION TO APPRISE THE BODY ON THE CIRCUMSTANCES SURROUNDING THE IMPLEMENTATION OF THE PROPOSED LEARNING CONTINUITY PLAN BY THE DIFFERENT SCHOOLS IN THE 1ST, 2ND AND 3RD DISTRICTS OF PANGASINAN

WHEREAS, the opening of School Year 2020-2021 is fast approaching and there is a need to ascertain the distance learning modalities to be adopted in the Province of Pangasinan;

WHEREAS, the Sangguniang Panlalawigan, upon its invitation during its Question Hour held on July 6, 2020 Regular Session, has been informed by the five (5) Schools Division Superintendents of the Province of Pangasinan on the different distance learning modalities proposed to be adopted by the different schools such as the online learning, television programs, radio programs, modular learning and combination of different learning modalities;

WHEREAS, the Sangguniang Panlalawigan has learned that the modular learning approach is the most preferred distance learning modality by learners of the different schools in Pangasinan;

WHEREAS, reports have reached the Sangguniang Panlalawigan that some teaching and learning materials were already distributed to the different schools in the Province;

WHEREAS, the Sangguniang Panlalawigan would like to know if online learning would go hand in hand with the modular learning approach considering that USBs are being provided by an education technology company to the schools in Pangasinan I;

WHEREAS, the Sangguniang Panlalawigan has already expressed its support to the Learning Continuity Plans of the schools divisions in Pangasinan, however, it is the aim of the Body to have a clearer picture as to the circumstances surrounding the implementation of the distance learning modalities in Pangasinan I Schools Division;

WHEREFORE, on motion of SP Member Von Mark R. Mendoza, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to invite, as they are hereby invited, the Regional Director of the Department of Education and the Public Schools District Supervisors of Pangasinan I to a Question Hour of the Sangguniang Panlalawigan on its August 3, 2020 Regular Session to apprise the Body on the circumstances surrounding the implementation of the proposed Learning Continuity Plan by the different schools in the 1st, 2nd and 3rd Districts of Pangasinan;
