APPROVING RESOLUTION NO. 404-112217 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE SECOND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF POZORRUBIO FOR CY 2017 FUNDED BY UNAPPROPRIATED BALANCE FROM SUPPLEMENTAL BUDGET NO. 1, EXCESS OF COLLECTION FOR UNFILLED POSITIONS OF POZORRUBIO, PANGASINAN IN THE AMOUNT OF SEVEN MILLION FOUR HUNDRED SEVENTY EIGHT THOUSAND SEVEN HUNDRED SIXTY FIVE PESOS AND SIXTY SEVEN CENTAVOS (P7,478,765.67)”

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 404-112217 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated the municipality’s 2nd Supplemental Annual Investment Program amounting to P7,478,765.67. This was endorsed through MDC Resolution No. 03, S-2017 dated November 17, 2017 to the Sangguniang Bayan and was subsequently approved by their Sangguniang Bayan thru Resolution No. 404-112217 dated November 22, 2017;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
