AMENDING PROVINCIAL RESOLUTION NO. 702-2020 ENTITLED “INVITING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO DELIVER HIS REPORT ON THE STATE OF THE PROVINCE BEFORE THE 10TH SANGGUNIANG PANLALAWIGAN ON ITS JULY 27, 2020 REGULAR (WEB-BASED/ONLINE) SESSION” TO JULY 28, 2020 SPECIAL (WEB-BASED/ONLINE) SESSION

WHEREAS, Provincial Resolution No. 702-2020 of the Sangguniang Panlalawigan dated July 13, 2020 invited the Honorable Governor, Amado I. Espino III, to deliver his Report on the State of the Province before the 10th Sangguniang Panlalawigan on its July 27, 2020 Regular (Web-Based/Online) Session;

WHEREAS, the President is mandated under the Constitution to deliver his State of the Nation Address (SONA) before a Joint Session of Congress every 4th Monday of July which is set on July 27 for this year;

WHEREAS, the Sangguniang Panlalawigan finds it necessary to hold a Special Session on July 28, 2020 instead in order for the Report not to coincide with the State of the Nation Address of the President and to enable the provincial government officials to have time and listen to the SONA;

WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario and all Members of the Sangguniang Panlalawigan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to amend, as it is hereby amended, Provincial Resolution No. 702-2020 entitled “Inviting the Honorable Governor, Amado I. 


