ORDINANCE ABOLISHING THE POSITION OF TWO (2) MIDWIFE III (SG-15) AND ONE (1) ADMINISTRATIVE AIDE IV (DRIVER II) SG-4 AND CREATING THE POSITIONS ADMINISTRATIVE AIDE II (SG-2) UNDER THE OFFICE OF THE RURAL HEALTH UNIT, MUNICIPAL MAYOR, GENERAL **SERVICES** OFFICE. **MDRRM** OFFICE, MUNICIPAL ACCOUNTING OFFICE, RURAL HEALTH UNIT, AND ONE (1) ADMINISTRATIVE AIDE III (DRIVER I) SG-3 UNDER THE OFFICE OF THE ROSALES MUNICIPAL INFIRMARY UNIT IN THE MUNICIPALITY OF ROSALES, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT**
