RESOLUTION NO. 72-2022

DECLARING MUNICIPAL ORDINANCE NO. 2021-04 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING THE GUIDELINES FOR THE REGISTRATION OF FISHING VESSEL THREE (3) GROSS TONNAGE AND BELOW IN THE MUNICIPALITY OF AGNO, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Municipal Ordinance No. 2021-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 132, 149 (3) and 447 (3) (i), (5) of R.A. No. 7160 and Republic Act No. 10601 otherwise known as “ Agricultural and Fisheries Mechanization Law”, Joint Memorandum Circular No. 2018-02 and Executive Order No. 305 or the “ Devolving to Municipal and City Government the Registration of Fishing Vessels Three (3) Gross Tonnage Below and R.A. No. 8550 known as the “ Philippine Fisheries Code of 1998.;

WHEREAS, however, the Sangguniang Bayan shall consider the points raised by the Provincial Legal Officer stated in her opinion dated December 29, 2021;

WHEREAS, subject ordinance shall take effect after compliance with the requirements posting and publication pursuant to Section 511 of RA No. 7160;
