**PROVINCIAL RESOLUTION NO. 722-2021**

**INVITING THE REGIONAL AND DISTRICT LAND TRANSPORTATION OFFICES (LTO) TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS SEPTEMBER 13, 2021 REGULAR (PHYSICAL) SESSION TO ENLIGHTEN THE BODY ON THE MATTER OF THE IMPLEMENTATION OF MANDATORY VEHICLE TESTING BY PRIVATE MOTOR VEHICLE INSPECTION CENTERS (PMVICs) IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, Department of Transportation Memorandum Circular No. MC-SC-2021-02 dated July 5, 2021 provides for the implementation of a Geographical Area of Responsibility (GAOR) for Renewal of Registration for Light Vehicles and Motorcycles;

**WHEREAS**, Private Motor Vehicles Inspection Centers (PMVICs) vehicle tests will be mandatory in some areas including the Province of Pangasinan;

**WHEREAS**, the reimplemention of the program has again ignited protests and caused unnecessary uproars from particular sectors of the community especially motor vehicle owners;

**WHEREAS**, the operation of PMVICs is again untimely amid the public health crisis;

**WHEREAS**, the implementing rules and regulations of the program need to be laid down first prior to its full implementation in the Province of Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nicholi Jan Louie Q. Sison and Rosary Gracia P. Perez-Tababa, duly seconded, it was –




