**PROVINCIAL RESOLUTION NO. 723-2021**

**REQUESTING HIS EXCELLENCY, PRESIDENT RODRIGO R. DUTERTE, TO INCLUDE IN THE SIGNING OF THE MEMORANDUM OF AGREEMENT THE LEAGUE OF MUNICIPALITIES PROVINCIAL CHAPTER PRESIDENT AND BARANGAY HEALTH WORKERS PROVINCIAL FEDERATION PRESIDENT IN THE IMPLEMENTATION OF THE PROGRAM GRANTING SPECIAL RISK ALLOWANCE TO HEALTHCARE WORKERS**

**WHEREAS**, Proclamation No. 922, Series of 2020 declared a State of Public Health Emergency in recognition of the COVID-19 public health event as a threat to national security, and prompted a whole-of-government approach in addressing the COVID-19 outbreak in the country;

**WHEREAS**, RA No. 11494, otherwise known as the "Bayanihan to Recover as One", affirmed the existence of a continuing national emergency in view of the unabated spread of COVID-19 and the economic disruption ensuing from it;

**WHEREAS**, Administrative Order No. 36 issued by the Office of the President authorized the grant of Special Risk Allowance (SRA) to private and public health workers directly catering to or in contact with COVID-19 patients during the state of national emergency;

**WHEREAS**, Administrative Order No. 42 of the Office of the President authorized the extension until the end of June this year the grant of Special Risk Allowance (SRA) to frontline public health workers;

**WHEREAS**, a Memorandum of Agreement shall be entered into and signed between the Department of Health and the Local Government Units for the grant of Special Risk Allowance to healthcare workers;
