DECLARING RESOLUTION NO. 165. S-2020 OF THE SANGGUNIANG BAYAN OF **BINMALEY**, PANGASINAN, **ENTITLED "GRANTING THE AMOUNT OF P250.00 PER DAY FOR** THOSE EMPLOYEES (REGULAR EMPLOYEES, JOB ORDER WORKERS AND CONTRACT OF SERVICE) WHO PHYSICALLY **REPORT FOR WORK FROM MARCH 18, 2020 UNTIL MAY 15, 2020** AS COVID-19 HAZARD PAY DURING THE IMPLEMENTATION OF THE ENHANCED COMMUNITY QUARANTINE IN THE **MUNICIPALITY OF** BINMALEY THEREBY AMENDING **RESOLUTION NOS. 53 AND 152, S-2020" AS WITHIN THE** CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 165, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Local Finance Committee, have conducted initial review and study on said resolution and found out that the same is in compliance with the provisions of Administrative Order No. 26 dated March 23, 2020 of the Office of the President and implemented by Budget Circular No. 2020-01 dated March 24, 2020;

WHEREAS, the benefit is granted to government employees who physically report for work during the implementation of Enhanced Community Quarantine in an amount not exceeding P500.00/day per person;

WHEREAS, the Municipality of Binmaley is granting P250.00/day Hazard Pay due to insufficiency of funds. This is in accordance with Item 7.0 of Budget Circular No. 2020-01: should an LGU have an insufficient funds to fully cover the COVID-19 Hazard Pay at the rate of P500.00/day per person, a lower but uniform rate maybe granted for all qualified personnel;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Resolution No. 165, S-2020 of the Sangguniang Bayan of **Binmaley**, Pangasinan, entitled "Granting the amount of P250.00 per day for those employees (Regular Employees, Job Order Workers and Contract Of Service) who physically report for work from March 18, 2020 until May 15, 2020 as Covid-19 Hazard Pay during the implementation of the Enhanced Community Quarantine in the Municipality of Binmaley thereby amending Resolution Nos. 53 and 152, S-2020" as within the conferred powers of the Sangguniang Bayan to enact;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Binmaley, Pangasinan, for its information and guidance.
