APPROVING RESOLUTION NO. 040-2018 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2018 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 040-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of the of the Local Government Code of 1991. The Local Development Council of Labrador, Pangasinan had identified items in their Supplemental Investment Program for CY 2018. This was endorsed to the Sangguniang Bayan for approval on November 29, 2018 thru MDC Resolution No. 003, S-2018 and was favorably acted upon by the Sangguniang Bayan on December 10, 2018 thru SB Resolution No. 040, S-2018;

WHEREAS, the Supplemental Investment Program of the municipality covers the granting of Collective Negotiation Agreement incentive to municipal officials and employees;
