**RESOLUTION NO. 731-2020**

**APPROVING RESOLUTION NO. 2020-168 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 4, CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-168 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council-Executive Committee of Mangaldan prepared their Supplemental Annual Investment Plan (SAIP) No. 4 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 4, S-2020 dated June 29, 2020 to the Sangguniang Panlungsod for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2020-168 dated July 3, 2020;

**WHEREAS**, the municipality’s Supplemental AIP No. 4 for CY 2020 has a total investment requirement of P10,687,123.68, including the cost for the purchase of transportation vehicle from the Performance Challenge Fund;

**WHEREAS**, funding for the Supplemental AIP will be sourced from the reversion of certain funds (other personnel benefits) and savings of the LGU as embodied in their Supplemental Budget No. 4, FY 2020 in the amount of P8,387,123.68, and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2020-04 dated July 3, 2020. The remaining amount of P2,300,000.00 will be funded by the Performance Challenge Fund;


