**APPROVING RESOLUTION NO. 084-2021 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL NO. 3 OF THE ANNUAL INVESTMENT PROGRAM, CALENDAR YEAR 2021 OF THE MUNICIPALITY OF AGNO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its SB Resolution No. 084-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, the Local Development Council of Agno, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2021 with a total investment requirement of P8,074,916.00 which was endorsed through MDC Executive Committee Resolution No. 03-2021 dated July 21, 2021;

**WHEREAS**, SAIP No. 2 for CY 2021 of the municipality covers the fund augmentation mainly for the Maintenance and Other Operating Expenses and Capital Outlay of some offices;


