APPROVING SB RESOLUTION NO. 25, S-2021 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED, "APPROVING THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPALITY OF BANI, PANGASINAN FOR THE CALENDAR YEAR 2021". (RESUBMITTED)

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 25, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, the Local Development Council of Bani, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2021. This was endorsed by the Local Development Council to the Sangguniang Bayan on May 10, 2021 through MDC Resolution No. 2021-04;

WHEREAS, the AIP of Bani, Pangasinan was formulated following the prescribed AIP Summary Form and covers a) all the regular budgetary requirements for the operation of the different municipal offices broken down into PS, MOOE and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the

20% development fund, c) Disaster Risk Reduction Management Plan, d) Local Climate Change Action Plan; e) Peace and Order Plan, f) Local Nutrition Action Plan; g) Annual Cultural Development Plan; and h) PPAs in pursuance of the objectives of GAD, Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities of the LGU and PPAs to address the Acquired Immune Deficiency Syndrome and Problems on Illegal Drugs;

WHEREAS, the proposed AIP of Bani for CY 2021 has an investment requirement of P193,756,372.68, Funding support for the implementation of said AIP is embodied in their proposed Annual Budget for 2021, which was passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2021 on June 8, 2021 and approved by the Municipal Mayor on June 23, 2021;

WHEREAS, this AIP is in accordance with Section 287 of LGC of 1991. Twenty percent (20%) of the LGU's IRA (P169,041,635.00), which is equivalent to P33,808,327.00 is allocated for development projects. These development programs/projects conform to the Joint DBM-DOF-DILG Memorandum Circular No. 1, dated November 4, 2020. (Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects):

WHEREAS, the Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund in the amount of P9,441,331,75, is in conformity to Section 21 of RA 10121. The programs/projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P6,608,932,22 were based on NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government(Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). The 2019-2024 LDRRM Plan was reviewed and certified by the Office of the Civil Defense Regional Office I;

WHEREAS, the LGU of Bani had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender s and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the DILG Provincial Office and were found to be fully compliant in form and in contents with the provisions of the Joint Memo-Circular (DBM, PCW, DILG & NEDA) No. 2016-01-Amenmdments to JMC 2013-01 or the Guidelines on the Localization of the Magna Carta of Women;
