DECLARING ORDINANCE NO. 2021-33 OF THE **SANGGUNIANG** OF ALAMINOS, **PANLUNGSOD** "AN PANGASINAN, **ENTITLED ORDINANCE** TRANSFERRING FIVE (5) POSITIONS UNDER THE **DEPARTMENT** THE **EXECUTIVE OF** GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT
