#### **RESOLUTION NO. 741-2021**

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2021 OF BASISTA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P3,578,427.36 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS,** the Sangguniang Bayan of Basista, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2021 involving total appropriations of P3,578,427.36 which was enacted on July 26, 2021 through Appropriation Ordinance No. 01, S-2021;

**WHEREAS,** the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding sources for the subject Supplemental Budget were determined in accordance to Section 321 of R.A. No. 7160 and Article 414(a) of its Implementing Rules and Regulations (IRR) as amended by Administrative Order No. 47 dated April 12, 1993;

- 2. The utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DBM-DOJ-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: "Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects";
- 3. All programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated 08 March 2007; and
- 4. All procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative In Its Entirety the Supplemental Budget No. 1 for Calendar Year 2021 of Basista, Pangasinan;
