**DECLARING ORDINANCE NO. 157, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED, "AN ORDINANCE RETITLING THE POSITION OF BOOKKEEPER I (SG 8), PLANTILLA NO. 71 AND ACCOUNTING CLERK II (SG 6), PLANTILLA NO. 72 UNDER THE OFFICE OF THE MUNICIPAL ACCOUNTANT TO CONFORM WITH THE CSC MEMORANDUM CIRCULAR NO. 10, S-2005, ENTITLED "ADMINISTRATIVE POSITIONS IN THE ADMINISTRATIVE SERVICES GROUP UNDER THE GENERAL ADMINISTRATIVE SERVICE OF THE POSITION CLASSIFICATION PLAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 157, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, based on the plantilla of personnel under the Office of the Municipal Accountant, there is also a position of Senior Bookkeeper, Salary Grade 9 and the same shall also be converted to Administrative Assistant III, Salary Grade 9;
