APPROVING SB RESOLUTION NO. 19, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 02 CY 2020 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 19, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2020, endorsed to the Sangguniang Bayan for approval on May 12, 2020 by the Municipal Development Council thru Resolution No. 2020-04 and was favorably acted upon by the Sangguniang Bayan on May 14, 2020 thru SB Resolution No. 19, S-2020;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality covers fund augmentation for personal services and programs/projects/actvitities to address the effects of COVID-19 pandemic to be funded from the savings from Personal Services (P1,293,777.00), Bayanihan Grant to Cities and Municipalities (P13,575,054.00) and realigned 20% development fund (P12,487,528.00). The realignment of development fund CYs 2017, 2019 and 2020 was endorsed by the Municipal Development Council thru Resolution No. 2020-03 on May 12, 2020. This is in accordance with Local Budget Circular No. 124 dated March 26, 2020 and DILG-DBM Joint Memorandum Circular No. 01, dated March 27, 2020;

WHEREAS, the project to be funded from the Bayanihan Grant to Cities and Municipalities are based on Local Budget Circular No. 125 of the Department of Budget and Management dated April 7, 2020 – "Guidelines on the Release and Utilization of Bayanihan Grant to Cities and Municipalities";

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P27,356,359.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01 for Calendar Year 2020 which was approved by their Sangguniang Bayan on May 14, 2020 thru Appropriation Ordinance No. 02, S-2020 and approved by the Municipal Mayor on June 2, 2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
