**PROVINCIAL RESOLUTION NO. 759-2021**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING BETWEEN AND AMONG THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA), THE MUNICIPAL GOVERNMENT OF LINGAYEN, AND THE CENTER FOR PANGASINAN STUDIES FOR THE IMPLEMENTATION OF THE CULTURAL MAPPING PROJECT IN THE MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN**

**WHEREAS**, the Province of Pangasinan recognizes the important role of the National Commission for Culture and the Arts (NCCA) in its pursuit to conserve, promote and protect the nation's historical and cultural heritage;

**WHEREAS**, the NCCA has launched the Cultural Mapping Program with the aim to identify, protect and preserve the cultural heritage of the local government units;

**WHEREAS**, the Province of Pangasinan, through the Municipality of Lingayen, have been chosen for the conduct of the cultural mapping program and a corresponding Memorandum of Agreement (MOA) is needed before the said implementation;

**WHEREAS**, the MOA shall serve as a vehicle for collaboration efforts between and among the Province of Pangasinan, the NCCA, the Municipal Government of Lingayen, and the Center for Pangasinan Studies in order to distinguish, record, classify and analyze the cultural resources of said locality;

**WHEREAS**, in the above purpose, the Memorandum of Understanding shall be entered into and signed between and among the Province of Pangasinan, represented by Governor Amado I. Espino III, the National Commission for Culture and the Arts, represented by Chairman Arsenio J. Lizaso, the Municipal Government of Lingayen, represented by Mayor Leopoldo N. Bataoil, and the Center for Pangasinan Studies, represented by Executive Director Perla E. Legaspi;
