**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its SB Resolution No. 2021-48 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, the Local Development Council of Bolinao, Pangasinan had identified items in their prepared their Supplemental Investment Program No. 3 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on July 16, 2021 by the Municipal Development Council through MDC Resolution No. 4, Series of 2021;


