RECOMMENDING TO THE OFFICE OF THE PRESIDENT THROUGH THE SECRETARY OF THE DEPARTMENT OF EDUCATION THE IMMEDIATE RELIEF OF DR. SHEILA MARIE A. PRIMICIAS AS OFFICER-IN-CHARGE-SCHOOLS DIVISION SUPERINTENDENT OF PANGASINAN I SCHOOLS DIVISION PENDING THE INVESTIGATION OF COMPLAINTS FILED AGAINST HER

WHEREAS, education has always been given priority by the past and present administrations of the Provincial Government of Pangasinan due to its paramount importance;

WHEREAS, the integral manner involving the integrity, harmony, consistency and continuity of the programs of Pangasinan I Schools Divisions are vital in order to sustain the momentum gained by the Province;

WHEREAS, the Sangguniang Panlalawigan as the highest legislative body of the Province expresses its grave concern over some issues raised surrounding the management of Pangasinan I Schools Division, particularly the Officer-in-Charge-Schools Division Superintendent herself, Dr. Sheila Marie A. Primicias;

WHEREAS, the Sangguniang Panlalawigan has received an official report that a complaint filed against the Officer-in-Charge-Schools Division Superintendent is pending investigation before the Regional or National Office of the Department of Education and a case is also lodged against her before the Ombudsman for that matter;

WHEREAS, pending the investigation of the cases filed against the Officer-in-Charge-Schools Division Superintendent, the Sangguniang Panlalawigan is of the belief that her continuance in office could influence the witnesses or pose a threat to the safety and integrity of the records and other pieces of evidence;

NOW, THEREFORE, on motion of SP Member Von Mark R. Mendoza and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan of Pangasinan to recommend, as it is hereby recommended, to the Office of the President through the Secretary of the Department of Education the immediate relief of Dr. Sheila Marie A. Primicias as Officer-In-Charge Schools Division Superintendent of Pangasinan I Schools Division pending the investigation of complaints filed against her;
