APPROVING RESOLUTION NO. 2020-188 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 08 (SAIP NO. 08) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO FIFTEEN MILLION EIGHT HUNDRED THIRTEEN THOUSAND SEVEN HUNDRED NINETY-ONE PESOS AND SIXTY CENTAVOS (P15,813,791.60)”

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2020-188 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Investment Program No. 8 for CY 2020. This was endorsed to the Sangguniang Panlungsod for approval on October 20, 2020 by the City Development Council through CDC Executive Committee Resolution No. 08, S-2020;

WHEREAS, the Supplemental Investment Program No. 8 of the city covers fund augmentation for the Personal Services and Maintenance and Other Operating Expenses of some City Offices;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P15,813,791.60. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 05, CY 2020, which was passed and approved by their Sangguniang Panlungsod on November 17, 2020 thru Appropriation Ordinance No. 2020-05 and approved by the City Mayor on November 25, 2020;


