**DECLARING MUNICIPAL ORDINANCE NO. 2020-02 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION III AND IV OF MUNICIPAL ORDINANCE NO. 200-03 ENTITLED, "ADOPTING THE USE OF CITATION TICKET FOR VIOLATIONS IN THE MUNICIPALITY OF ALCALA, PANGASINAN AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**


