**APPROVING RESOLUTION NO. 76, S-2021 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 4 FOR CY 2021 OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN AMOUNTING TO P2,613,757.49 FROM THE REALIGNMENT OF VARIOUS FUNDS TO PERFORMANCE-BASED BONUS AND FINANCIAL ASSISTANCE FOR JOB ORDERS DUE TO PANDEMIC AND PROVIDING APPROPRIATIONS THEREOF”**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its SB Resolution No. 76, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of San Fabian, Pangasinan prepared the LGU’s Supplemental Annual Investment Program No. 4 for CY 2021 and endorsed the same to the Sangguniang Bayan of San Fabian, Pangasinan through MDC Resolution No. 10, S-2021 dated May 31, 2021;

**WHEREAS**, said Supplemental AIP which has an investment requirement of P2,613,757.49 covers the granting of Performance-Based Bonus to employees and financial assistance to Job Orders of the LGU;


