APPROVING MUNICIPAL RESOLUTION NO. 2018-76 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 FOR CALENDAR YEAR 2018 OF THE MUNICIPALITY OF ALCALA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Resolution No. 2018-76 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, has conducted initial review and study on said resolution and found out that the Local Development Council of Alcala, Pangasinan has formulated the municipality’s Supplemental Investment Program No. 4 and endorsed to the Sangguniang Bayan for approval thru MDC Executive Committee Resolution No. 2018-04 dated November 19, 2018. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 2018-76 dated November 19, 2018. This is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality with an investment requirement amounting to P3,765,224.62 covers fund augmentation for the personal services and implementation of disaster risk reduction and management programs/activities of the municipality;
