RESOLUTION NO. 81-2020

DECLARING ORDINANCE NO. 04-2019 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING THE USE OF MOTORCYCLE OR TRICYCLE WITHOUT MUFFLERS OR THOSE THAT ARE DEFECTIVE OR HAVE BEEN MODIFIED WHICH INCREASE THE SOUND EMITTED AND PENALIZING OWNERS AND DRIVERS THAT CONTRIBUTE TO NOISE POLLUTION IN THE ENVIRONMENT WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Ordinance No. 04-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (2) (vi), (5) (v) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall take into consideration the observations of the Provincial Legal Officer stated in her opinion dated November 25, 2019;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication and posting pursuant to Sections 59 and 511 (a) of RA 7160;
