APPROVING RESOLUTION NO. 2021-39 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 02 OF THE SUPPLEMENTAL BUDGET NO. 2 OF THE MUNICIPALITY OF SAN MANUEL”

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its SB Resolution No. 2021-39 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of San Manuel, Pangasinan has formulated and endorsed to the Sangguniang Bayan the municipality’s Supplemental Investment Program No. 02 through MDC Resolution No. 02, S-2021 dated August 6, 2021;

WHEREAS, the subject Supplemental AIP has an investment requirement amounting to P600,000.00 which covers implementation of various development projects for the improvement of the lives of the people living in the community;

WHEREAS, to support the implementation of the programs embodied in Supplemental AIP No. 02, the Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 02, Series of 2021 dated August 11, 2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Manuel, Pangasinan;
