OF THE APPROVING SB RESOLUTION NO. 071-2020 PANGASINAN. BAYAN OF MALASIQUI, SANGGUNIANG ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 02-2020 OF THE MUNICIPALITY OF MALASIOUI, PANGASINAN IN THE AMOUNT OF SIX MILLION SEVEN HUNDRED EIGHT THOUSAND THREE HUNDRED SIXTY (P6,708,360.00) PESOS"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 071-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 02. This was endorsed by the Council thru MDC Resolution No. 03-2020 dated July 15, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 071-2020 dated July 15, 2020;

WHEREAS, said Supplemental AIP, which has a total investment requirement of P6,708,360.00, covers the payment for the First Tranche of the Modified Salary for LGU personnel for 12 months, and Hazard Pay for the COVID-19 frontliners;
