DECLARING ORDINANCE NO. 2021-25 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE FOLLOWING TWO (2) POSITIONS UNDER THE EXECUTIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN: CITY GOVERNMENT ASSISTANT DEPARTMENT HEAD I UNDER THE CITY HEALTH OFFICE AND CITY GOVERNMENT ASSISTANT DEPARTMENT HEAD I UNDER THE CITY AGRICULTURE OFFICE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2021-25 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
