WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 230-112218, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

This was subsequently approved by their Sangguniang Bayan thru Resolution No. 230-112218 dated November 22, 2018. This is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991;
