RESOLUTION NO. 830-2021

DECLARING ORDINANCE NO. 2021-28 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THREE (3) POSITIONS UNDER THE LEGISLATIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF ALAMINOS CITY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No 2021-28 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 76 and 458 (a) (1) (viii) of R.A. WHEREAS, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, 59 (c), and 511(a) of RA 7160 are complied with;


