DECLARING ORDINANCE NO. 2021-28 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THREE (3) POSITIONS UNDER THE LEGISLATIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF ALAMINOS CITY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No 2021-28 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
