APPROVING SB RESOLUTION NO. 127-2021 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 002-2021 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN IN THE AMOUNT OF THIRTY-NINE MILLION SIX HUNDRED THOUSAND (P39,600,000.00) PESOS”

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 127-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 02, CY 2021 through MDC Resolution No. 02-2021 dated August 9, 2021 to the Sangguniang Bayan for approval;

WHEREAS, said Supplemental AIP, which has a total investment requirement of P39,600,000.00 covers augmentation funds for Personal Services and Maintenance and Other Operating Expenses (MOOEs) of the LGU;

WHEREAS, funding support for the Supplemental AIP will be sourced from the LGU’s Savings, as embodied in their Supplemental Budget No. 02 FY 2021, and enacted by their Sangguniang Bayan through Appropriation Ordinance No.002-2021 dated August 25, 2021;
