PROVINCIAL RESOLUTION NO. 84-2020

REQUESTING THE LOCAL GOVERNMENT UNIT AND THE PHILIPPINE NATIONAL POLICE OF SAN FABIAN, PANGASINAN TO UPDATE THE SANGGUNIANG PANLALAWIGAN ON THE REPORTED INCIDENCES OF STONE THROWING IN THE SAID MUNICIPALITY

WHEREAS, the Sangguniang Panlalawigan expresses deep concern over the reported incidences of stone throwing in the Municipality of San Fabian, Pangasinan;

WHEREAS, one recent incident happened in Barangay Mabilao on the eve of January 26, 2020 wherein the provincial bus of Pangasinan itself plying the area with passengers on board was the victim of stone throwing;

WHEREAS, it is the aim of the Sangguniang Panlalawigan that preventive measures be undertaken by the concerned authorities to address the same immediately to avoid its recurrence and in order not to destroy the image of the Province especially so if the victims are not from Pangasinan;

WHEREAS, the Sangguniang Panlalawigan is further requesting that a full investigative report be submitted to the august Body the soonest possible time;

WHEREAS, it is the primordial concern of the Sangguniang Panlalawigan to protect not only the safety of the people of Pangasinan but also local and foreign visitors;
