DECLARING MUNICIPAL ORDINANCE NO. 15-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITION OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT ASSISTANT (ADMINISTRATIVE ASSISTANT II) OF LGU MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
