#### RESOLUTION NO. 843-2021

DECLARING MUNICIPAL ORDINANCE NO. 119, S-2021 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ANY PERSON, INSTITUTION, CORPORATION GROUP OR ORGANIZATION WHO SHALL ENGAGE IN THE SALE, DISTRIBUTION OR ADMINISTRATION OF COVID-19 VACCINES FOR GAIN, INCOME OR PROFIT, WHILE THE COUNTRY IS IN A STATE OF PUBLIC HEALTH EMERGENCY AND WITHOUT FULL MARKET AUTHORIZATION, AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Municipal Ordinance No. 119, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (i) and (iii) and (3) (ii) of R.A. No. 7160;

**WHEREAS**, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;
