**PROVINCIAL RESOLUTION NO. 853-2021**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE FOR THE IMPLEMENTATION OF THE ENDOWMENT FUND PROGRAM AT THE URDANETA DISTRICT HOSPITAL**

**WHEREAS**, the Endowment Fund Program (EFP) is a Philippine Charity Sweepstakes Office (PCSO) program that provides funding support directly to government hospitals to augment the medical and health care needs of poor and disadvantaged patients;

**WHEREAS**, the Provincial Government of Pangasinan, through the Urdaneta District Hospital, shall be the Endowment Fund Program Partner Hospital of the PCSO in the implementation of the EFP;

**WHEREAS**, the Program shall be beneficial to the people of Pangasinan especially for charity patients who are confined and are receiving outpatient management in the said hospital, more so that its dialysis facility has recently been established and is extending services to sustain the required dialysis sessions of the underprivileged;

**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III, and the Philippine Charity Sweepstakes Office, represented by its General Manager, Royina M. Garma;


