DECLARING ORDINANCE NO. 10, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 8-S-2020, "AN ORDINANCE CREATING THE POSITION OF SOCIAL (MUNICIPAL GOVERNMENT OFFICER V WELFARE I), SALARY GRADE 24 IN THE HEAD DEPARTMENT MUNICIPALITY OF SAN FABIAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 10, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the position of Social Welfare Officer V (Municipal Government Department Head), SG 24, was created by the Sangguniang Bayan through Ordinance No. 8, S-2020, however, the position title is changed to Municipal Government Department Head I (Municipal Social Welfare and Development Officer), Salary Grade 24, under the present ordinance;

WHEREAS, since the ordinance merely changes the position title and it does not need additional appropriation, said ordinance is within the conferred powers of the Sangguniang Bayan to enact;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;
