DECLARING MUNICIPAL ORDINANCE NO. 2021-05 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 3 SUBPARAGRAPHS 6 AND 7 OF MUNICIPAL ORDINANCE NO. 2019-10" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

No. 7160;
