RESOLUTION NO. 862-2020

DECLARING ORDINANCE NO. 12, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ANY PERSON WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN FROM COMMITTING ANY ACT WHICH CAUSES STIGMA, DISGRACE, SHAME, HUMILIATION, HARRASSMENT OR DISCRIMINATING AGAINST A PERSON INFECTED OR UNDER INVESTIGATION OR MONITORING DUE TO COVID-19 VIRUS AND IMPOSING PENALTIES THEREIN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 12, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (xii) of RA 7160; Section 5 (General Provisions) of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, the Sanggunian shall consider the points raised by the Provincial Legal Officer stated in her opinion dated September 4, 2020;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;




