RESOLUTION NO. 863-2020

DECLARING MUNICIPAL ORDINANCE NO. 2020-03 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "AN ORDINANCE PRESCRIBING THE EMERGENCY PROVISIONAL FARE MATRIX FOR TRICYCLE-FOR-HIRE AMID COVID-19 AND THEREBY SUSPENDING THE IMPLEMENTATION OF MUNICIPAL ORDINANCE NO. 2008-03 (AN ORDINANCE ENACTING A NEW TRICYCLE FARE RATES IN THE MUNICIPALITY OF ALCALA, PANGASINAN) UNTIL THE SITUATION RETURNS TO NORMAL AS OFFICIALLY DECLARED BY THE AUTHORITIES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2020-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (3) (vi) of RA 7160;

WHEREAS, the Sanggunian shall consider the points raised by the Provincial Legal Officer stated in her opinion dated August 24, 2020;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirement of public hearing and publication pursuant to Section 6 of the Department of Transportation and Communications Department Order No. 2008-23;
