APPROVING RESOLUTION NO. 37A-2021 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 CY 2021 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its SB Resolution No. 37A-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that Local Development Council of San Jacinto, Pangasinan prepared the municipality’s Supplemental Investment Program No. 1 for CY 2021 which was endorsed to the Sangguniang Bayan through MDC Resolution No. 2021-01 dated January 15, 2021;

WHEREAS, the Supplemental Investment Program No. 3 which has a total investment requirement of P32,346,918.00 covers various agri-infrastructure support projects for tobacco farmers of the municipality;

WHEREAS, the proposed projects to be funded from the share of the LGU from Tobacco Excise Tax are based on R. A. No. 8240 and Local Budget Memorandum No. 81 of the Department of Budget and Management;
