RESOLUTION NO. 866-2020

DECLARING MUNICIPAL ORDINANCE NO. 20-005 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 6 (PENALTIES) OF MUNICIPAL ORDINANCE NO. 20-003 OF THE SANGGUNIANG BAYAN, OTHERWISE KNOWN AS "MANDATORY WEARING OF FACE MASK ORDINANCE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 20-005 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) of RA 7160;

WHEREAS, the power of the Sangguniang Bayan to enact ordinance and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

WHEREAS, the Sanggunian shall consider the points raised by the Provincial Legal Officer stated in her opinion dated September 02, 2020;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;


