RESOLUTION NO. 867-2020

DECLARING MUNICIPAL ORDINANCE NO. 01, S-2020 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "AN ORDINANCE STRICTLY REQUIRING ALL DRIVERS, OPERATORS, OWNERS OF PUBLIC UTILITY TRICYCLES FOR THE AVAILABILITY OF PRECAUTIONARY PROTOCOLS IN THEIR VEHICLE/S DURING THE PERIOD OF COMMUNITY QUARANTINE AND FOR ANY EXTENSION THEREOF IN THE MUNICIPALITY OF STO. TOMAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Municipal Ordinance No. 01. S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (3) (vi), (5) (xii) of RA 7160; and Section 10 of Executive Order 0059-2020 of the Province of Pangasinan;

WHEREAS, the Sanggunian shall consider the points raised by the Provincial Legal Officer stated in her opinion dated August 26, 2020;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;




