RESOLUTION NO. 868-2021

DECLARING MUNICIPAL ORDINANCE NO. 4, S-2021 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE LOT LOCATED AT BARANGAY AMARONAN, UMINGAN, PANGASINAN, COVERED BY TAX DECLARATION NO. 43-0005-0089 AND TCT NO. 028-2014000507 REGISTERED AND OWNED BY CHERRY AQUINO CHAN FROM AGRICULTURAL FOR SPECIAL USE FOR THE ESTABLISHMENT OF MOUNTAIN GARDEN MEMORIAL" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Ordinance No. 4, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II, and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Umingan has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2003-2012, however, needs to be updated;


