DECLARING MUNICIPAL ORDINANCE NO. 2020-08 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 2018-03 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2020-08 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the power of the Sanggunian to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

WHEREAS, the new projects, Construction of Legislative Building and the Acquisition of Lot for common parking area, are both included in the CY 2020 Supplemental Investment Program No. 04;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;
