REQUESTING THE PHILIPPINE COCONUT AUTHORITY TO PROVIDE AT LEAST 300,000 COCONUT SEEDLINGS TO THE PROVINCE OF PANGASINAN TO BE DISTRIBUTED ESPECIALLY TO THE FARMERS AND IRRIGATORS

WHEREAS, the Philippine Coconut Authority is the proper government agency tasked to develop the coconut industry to its full potential;

WHEREAS, the quality of soil in Pangasinan is best suited for fruits, vegetables and palay thereby it is considered as one of the top producing provinces in the region in terms of those crops;

WHEREAS, the Provincial Government of Pangasinan also wants to exert more efforts to improve the coconut industry in the Province so it will not be depending much on local products of other provinces;

WHEREAS, in order to strengthen local sources of coconuts in Pangasinan, there is a need to promote the planting of more coconuts in the Province;




