RESOLUTION NO. 877-2020

DECLARING ORDINANCE NO. 06, S-2020 OF THE SANGGUNIANG PANGASINAN, ENTITLED BAYAN OF CALASIAO, ORDINANCE MANDATING THE PROPER USE OR WEARING OF FACE **MASKS** AND THE PRACTICE **OF** SOCIAL DISTANCING/PHYSICAL DISTANCING BY ALL PERSONS IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CALASIAO DURING THE PERIOD OF COMMUNITY QUARANTINE AND FOR ANY EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 06, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-062; Provincial Ordinance No. 240-2020 and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of July 16, 2020;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her written opinion dated August 29, 2020;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;
