DECLARING MUNICIPAL ORDINANCE NO. 14, S-2021 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE PRESCRIBING THE PAYMENT OF FEES FOR THE USAGE OF COMFORT ROOMS LOCATED AT PUBLIC MARKET, TRIANGLE AREA, AUDITORIUM AND PEOPLE'S PARK ALL SITUATED IN BARANGAY POBLACION, BINMALEY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

No. 7160;

**WHEREAS**, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, 59 (c), and 511(a) of RA 7160 are complied with;
