DECLARING ORDINANCE NO. 95, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE PRESCRIBING THE RULES AND PROCEDURES IN ADMINISTRATIVE CASES BEFORE THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, AGAINST ANY ELECTIVE BARANGAY OFFICIAL" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Municipal Ordinance No. 95, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 60-68 Title Two Chapter 4 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 95, S-2020 of the Sangguniang Bayan of Lingayen, Pangasinan, entitled "An Ordinance prescribing the rules and procedures in administrative cases before the Sangguniang Bayan of Lingayen, Pangasinan, against any elective barangay official" as within the conferred powers of the Sanggunian to enact;
