DECLARING MUNICIPAL ORDINANCE NO. 012-2021 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING TEMPORARY FARE MATRIX OF TRICYCLE FOR HIRE DURING PANDEMIC IN THE MUNICIPALITY OF MALASIQUI, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 012-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 447 ((a) (3) (vi) of R.A. No. 7160; Section 11 (F) of Executive Order No. 0033-2020 of the Province of Pangasinan;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c), and 511(a) of RA 7160 are complied with;
